

2021 ANNUAL KMS KANSAS MANUFACTURING INDUSTRY QUESTIONNAIRE CONTEST RULES

NO PURCHASE OR PAYMENT REQUIRED TO ENTER OR WIN. VOID WHERE PROHIBITED.

The details regarding the prize(s) are included in each contest description and procedures for entering each contest are contained in the Official Rules below.

- 1. Eligibility: The "2021 Annual KMS Kansas Manufacturing Industry Questionnaire" contest ("Contest") is open to Kansas manufacturing employees who are legal residents of the contiguous United States and District of Columbia where permissible by law, who are at least 18 years old at the time of entry. Employees, officers and directors (including immediate family members (spouse, child, sibling, parent and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Kansas Manufacturing Solutions (the "Sponsor"), affiliated companies, subsidiaries, advertising and promotion agencies associated with the Contest are not eligible to participate or win a prize. Proof of employment, residency and age may be required. The Contest is subject to all applicable federal, state, and local laws, rules and regulations. Void outside where otherwise prohibited or restricted by law, rule or regulation. Entrants are eligible to win one (1) contest prize.
- **2. Sponsors/Administrator:** The Sponsor and Administrator of the Contest is Kansas Manufacturing Solutions ("KMS," "Sponsor" or "Administrator").

- **5. Entry:** Entry into Contest will be by submission of the entrant's email address at the end of the KMS Manufacturing Industry Questionnaire. Entries must be received within the Contest Period. One entry for each entrant name. There is no fee or charge to participate in this contest. Participation is free.
- **6. Selection of Winning Entries:** All entries will be entered into the appropriate drawing. Three (3) winners will be randomly selected by The Administrator on July 5, 2020. The Administrator, whose decisions will be final and binding in all matters related to the contest, will validate the Contest winners.
- **7. Prizes:** The first drawn name will have a choice of (1) one prize with an approximate value is \$500. Included items for selection are a Solo Stove Yukon XL Firepit, \$500 in Yeti merchandise, five \$100 gift cards, a \$500 gift card to Apple, or a \$500 gift card to Home Depot. The second drawn name will have a choice of (1) one prize with an approximate value is \$350. Included items for selection are \$350 in Yeti merchandise, three \$100 gift cards and one \$50 gift card, a \$350 gift card to Apple, or a \$350 gift card to Home Depot. The third drawn name will have a choice of (1) one prize with an approximate value is \$200. Included items for selection are \$200 in Yeti merchandise, two \$100 gift cards, a \$200 gift card to Apple, or a \$200 gift card to Home Depot. Odds of winning depend on the total number of eligible entries received during the Promotion Period.

Except where prohibited, all contest participants grant to Sponsor and its advertising agencies the right to use and publish his or her proper name, likeness, voice, opinion(s), and/or biographical information in any form of media used to promote Sponsor and/or the Contest, without receipt of additional compensation.
