

2022 Kansas Manufacturing Industry Questionnaire Contest Rules

NO PURCHASE OR PAYMENT REQUIRED TO ENTER OR WIN. VOID WHERE PROHIBITED.

The details regarding the prize(s) are included in each contest description and procedures for entering each contest are contained in the Official Rules below.

- 1. Eligibility: The "Kansas Manufacturing Solutions Kansas Industry Questionnaire" contest ("Contest") is open to Kansas manufacturing employees who are legal residents of the United States and are 18 years of age or older as of the Contest start date. Officers, employees, contractors, third party, and temporary employees of Kansas Manufacturing Solutions are not eligible to participate in this Contest.
